NEW LEASE AGREEMENT FOR THE OPENING OF A NEW NABE URAWA RESTAURANT AND A NEW CANTON HOUSE RESTAURANT IN HONG KONG

This announcement is made by Taste · Gourmet Group Limited (the “**Company**”) on a voluntary basis with the aim of updating the shareholders and potential investors of the Company and its subsidiaries (the “**Group**”) on the latest business plan and development of the Company.

The board of directors of the Company (the “**Board**” or “**Directors**”) is pleased to announce that, the Group through a wholly owned subsidiary of the Company entered into a new lease (the “**New Lease**”) for the opening of a new Nabe Urawa restaurant and a new Canton House restaurant in Hong Kong (the “**New Restaurants**”).

The agreement in respect of the New Lease is still subject to execution by the landlord.

The landlord is a major property developer and operator of premium shopping malls in Hong Kong. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, as at the date of this announcement, the landlord is an independent third party of the Company (as defined in the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The New Restaurants, Nabe Urawa and Canton House, Harbour City, Tsim Sha Tsui

The basic terms of the New Lease are as follows:

Location:	Gateway Arcade Shop 2307 and 2307A, Level 2
Lease Term:	4 years and 6 months
Lease Commencement Date:	15 April 2026

The new restaurants are expected to commence operations in Q3 2026.

This will be the Group's thirteenth Nabe Urawa restaurant and third Canton House restaurant.

The terms of the New Lease were determined after arm's length negotiations between the Landlord and the Group, with reference to the prevailing market rentals for properties of similar type, age and location.

Located next to the Star Ferry Pier in Tsim Sha Tsui, the Harbour City is largest shopping centre in Hong Kong that offers over 450 shops, 80 food and beverage outlets and 3 hotels (source: www.harbourcity.com.hk).
